The League agrees with the Course to play golf on **Wednesday** night for **16** weeks and expects to have **32** players. **The above information will be used to calculate the League's expected obligation.**

- The League will start play on **May 4, 2022**. League tee times will begin at **4:03 p.m.**
- Add any dates **league wishes to exclude**. _____
- Additional **excluded dates** will be noted in the Schedule prepared by the course.

GREENS FEES: Per player for nine holes of golf with cart is **\$32.00** per week. The League, by virtue of the league official's return of this agreement, acknowledges it will pay the invoiced amount on the League payment due date.

EXTRA GOLF: League members qualify for 25% off discount of regular greens fee rates Monday – Thursday at Eagle Eye and Hawk Hollow (cannot be combined with any other discounts). Payment for additional golf is due and payable before any extra golf is played.

RAIN: In the event of inclement weather, the Course reserves the right to cancel play either before or during play. If the Course cancels play, the Course will issue rain checks or schedule a make-up date. The League also has the option to cancel play due to inclement weather or other "emergency" situations. If the League cancels play, please notify the pro-shop as soon as possible. Either rain checks will be issued, or the night's play will be rescheduled.

RULES:

- Leagues must tee off during their assigned tee times and maintain proper pace of play.
- Proper golf attire is required.
- All league members shall observe Michigan laws regarding gambling, and the use of alcoholic beverages. Per Eagle Eye Golf & Banquet Center's liquor license ALL alcoholic beverages must be purchased from Eagle Eye Golf & Banquet Center facilities. No outside alcoholic beverages are allowed on premises.
- It is the responsibility of the league president to convey the rules to all league members.

PAYMENT TERMS:

Before any adjustments for Eagle Eye/Hawk Hollow Property Homeowners or Eagle Eye Employees, the total amount due per player will be: **\$512**. An invoice will be sent to the league secretary with the adjusted total amount due for the league prior to the league's first night of play.

- At least 50% of the adjusted amount due is due on the first night of League Play
- Any balance is due no later than July 1, 2022.
- Payments are required in ONE payment for the entire league in the form of cash, check or money order.
- Credit card payments for league dues are subject to a 4% processing fee.
- Payment may be made to the manager on duty at any course.

To ensure all Homeowner and/or Employee adjustments are made, please list the NAMES AND ADDRESSES of any Homeowner and/or the NAMES of the Employees that will be members of your league. This information will allow the Course to adjust the amount due by the league.

Return of this agreement with any changes will permit Eagle Eye Golf & Banquet Center to prepare an invoice and schedule.
